

## Stop-N-Go of Madison, Inc. November 2018 Sweepstakes - Official Rules

**NO PURCHASE NECESSARY TO ENTER OR CLAIM PRIZE. A PURCHASE WILL NOT INCREASE YOUR CHANCE OF WINNING. VOID WHERE PROHIBITED.**

**1. Eligibility.** The Stop-N-Go of Madison, Inc. November 2018 Sweepstakes (the "Sweepstakes") is open to residents of Wisconsin and Illinois only, who are age 18 years or older and have reached the age of majority in their state of residency at the time of entry. Employees (and their dependents and immediate household members) of Stop-N-Go of Madison, Inc., their advertising and promotional agencies and sponsoring companies are not eligible to participate. Void where prohibited by law. Sweepstakes is subject to all applicable federal, state and local laws.

**3. How to Enter.** To enter, download the FREE StopNGo Stores app in the App Store or Google Play. Click on a coupon to log in and register. Once registered, click on the Win Tickets to the UW Men's Basketball game. Complete the form. **4. Prizes/Approximate Retail Value ("ARV") in U.S. Dollars. One (1) Grand Prize** consisting of 4 tickets plus parking pass to the UW Badgers vs. Houston Baptist men's basketball game on 11/17/2018 (ARV: \$250). TOTAL ARV of all prizes is \$250.

**5. Drawing/Odds/Notification.** A random drawing for the Grand prize will be held on November 13, 2018. Odds of winning depend on the number of entries received. Winner will be notified by text and email on November 13, 2018.
