

Stop-N-Go of Madison, Inc. Post-Holiday Sweepstakes - Official Rules

NO PURCHASE NECESSARY TO ENTER OR CLAIM PRIZE. A PURCHASE WILL NOT INCREASE YOUR CHANCE OF WINNING. VOID WHERE PROHIBITED.

1. Eligibility. The Stop-N-Go of Madison, Inc. Post-Holiday Sweepstakes (the "Sweepstakes") is open to residents of Wisconsin and Illinois only, who are age 18 years or older and have reached the age of majority in their state of residency at the time of entry. Employees (and their dependents and immediate household members) of Stop-N-Go of Madison, Inc., Monster Energy Company, The Coca-Cola Company, their advertising and promotional agencies and sponsoring companies are not eligible to participate. 3. How to Enter. To enter, download the FREE StopNGo Stores app in the App Store or Google Play. Click on a coupon to log in and register. Once registered, click on the "Click here to win a Monster Energy Rolling Cooler and a \$50 StopNGo gift card" to enter. Complete the form.
